Criteria for Admission to IITArb. Panel :

1. Empanelment is only on application by the individual members of IITArb.
2. Candidates wishing to apply must satisfy the following criteria:
 - Demonstrate experience as arbitrator/DRB/DAB
 - Published at least one arbitral award / DRB / DAB recommendations within the last seven years.
 - Provide names of two referees (preferably Fellow of IITArb.)
 - Good standing and character including confirmation that he/she has not been found guilty by a Court or disciplinary tribunal for misconduct (A self declared statement)
3. IITArb reserves the right, in its absolute discretion, to admit or to refuse admission of any member to the Panel. In exercising its discretion, IITArb will have due regard to the qualifications, experience and standing of a candidate. Decision of empanelment committee will be final
4. IITArb will retain the candidate’s personal information along with supporting documents in a confidential manner.
5. However IITArb will be at liberty at its discretion, to supply such personal information to potential users of the panel.
6. Application without the prescribed fee will not be considered.
7. IITArb reserves the right, in its absolute discretion, to remove any person from the Panel at any time.
8. Empanelment fee – INR 3,000 in demand draft/cheque, favouring “Indian Institution of Technical Arbitrators” payable at par at Chennai, India.
9. This fee will be refunded in full in case the candidate is not considered for empanelment.
